Membership form

Membership in CALGARY WOODTURNERS GUILD “CWG” is open to anyone interested in any aspect of woodturning. It is CWG’s practice to send newsletters and an updated list of members (complete with contact information) to its membership the month following each general meeting. Membership fees are \$30/yr for members who request delivery via email; \$35/yr for members who request delivery by ordinary mail; and \$15/yr for full-time students and members who live more than 50 km from the centre of Calgary. Membership fee includes demonstrations, lectures and workshops, unless advised otherwise. CWG memberships are on a calendar year basis beginning January 1. Prorated reductions are made for new members who join later in the year.

PERSONAL INFORMATION PROTECTION POLICY

The Federal Government has enacted legislation beginning January 2004 to protect individuals’ information. It can affect you and our organization. The Personal Information Protection and Electronic Documents Act controls what information may be collected and how it may be used.

Currently CWG retains the following information for our members: name, address, phone number(s), email address and type of lathe. We use this information to contact members with regard to monthly or special meetings and for delivering specific information (such as newsletters). CWG may also contact members with information deemed interesting or beneficial – including items that may be commercial in nature (e.g. courses or products related to woodturning in general).

Name and telephone number information is included on a Membership List distributed to all members of CWG. This list is for the personal use of CWG members, and may not be used for commercial purposes, nor may it be supplied to non-members of CWG.

The Membership List IS NOT shared with any other organization, commercial or private, and the list will not be published on the CWG website.

To meet the intent of the Personal Information Protection and Electronic Documents Act, please advise us if you wish your information to be corrected or removed from our files. Without this information, CWG will not be able to contact you or provide any further CWG information, thereby effectively nullifying your CWG membership.

Your consent is required to allow CWG use of your information for the above stated purposes. CWG will deem that by becoming a member, you have agreed that CWG may use this information as outlined above and that you agree to the restricted use of the membership list.

If you have any questions or concerns, in this regard, kindly contact the executive of CWG.
